Application For Membership And Electric Service With Tallapoosa River Electric Cooperative, Inc., LaFayette, Alabama

The undersigned (hereinafter called the Applicant) hereby applies for membership in Tallapoosa River Electric Cooperative, Inc., a corporation, its successors and assigns, (hereinafter call the Cooperative) and the Applicant and the Cooperative agree as follows:

1. The Applicant acknowledges that this is an application for membership in the Cooperative. If application is not accepted by the Cooperative, the deposit amount will be returned to the Applicant.
2. When the Cooperative makes electric energy available to the Applicant, Applicant agrees to purchase from the Cooperative and pay monthly to the Cooperative for all electric energy used by the Applicant, in accordance with the rate schedule and rules and regulations established by the Cooperative. The minimum monthly charge for service under this contract will normally be that as provided for in the applicable rate, or as may be amended. (However, under special conditions, the minimum monthly charge may be as specified in the applicable rate or higher, depending upon terms of service agreement.)

If electric service is discontinued before fulfillment of this agreement by the Applicant, any amounts due for remainder of contract period will be billed in full with the final metered service bill and shall be due and payable with this final bill.

3. The Applicant hereby grants the Cooperative, its successors and assigns the right and easement to construct, operate, repair, and maintain on any lands owned by me and in or upon all streets, roads, or highways abutting said lands, its electric distribution and service lines and appurtenances, and also the right to cut, spray or trim trees necessary to keep them clear of all parts of the electric system.
4. Before service is initiated hereunder, Applicant will cause the premises to be served to be wired or re-wired if necessary in accordance with requirements and specifications of the National Electric Code (or other higher applicable standards), and agrees that all subsequent wiring of the premises will likewise be made in accordance with said codes. Applicant further, by submission of the application represents, covenants, agrees and warrants that all wiring, original and subsequent, is or will be prior to initiation of service, in full compliance with said codes and covenants and agrees to hold the Cooperative completely and absolutely harmless from any and all liability or responsibility for any property damage or personal injury sustained by applicant or any person or entity, caused by wiring of the premises.
5. The Applicant will comply with and be bound by the provisions of the By-Laws and the Rules and Regulations of the Cooperative now and as may be adopted from time to time by the Board of Trustees. The Applicant agrees to be responsible for any damages to the property of the Cooperative which is located on his premises.
6. The Cooperative shall pay for me an appropriate amount for annual subscription to "Alabama Living". It is agreed that the cost of this subscription shall reduce such funds in the same manner as would any other expense of the Cooperative.
7. Cooperative shall use reasonable diligence to provide a constant and uninterrupted supply of electric power and energy hereunder. If the supply of electric power and energy shall fail or be interrupted, or become defective through act of God or of the public enemy, or because of accident, labor troubles or any other cause beyond the control of Cooperative, Cooperative shall not be liable therefor or for damages caused thereby.

The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, its successors and assigns, and the contract for electric service shall continue in force from the date service is made available by the Cooperative to the Applicant, and thereafter until cancelled by written notice given by either party to the other at least thirty (30) days in advance.
